## 「星芒漫遊」親子單車互動裝置 – 條款及細則

- 「星芒漫遊」親子單車互動裝置 (以下稱為「活動」)的推廣期(以下稱為「推廣期」)為
  2025年11月13日至2026年1月4日(包括首尾兩日)。
