

## 「『脆』手可得」大作戰 – 條款及細則

1. 「『脆』手可得」大作戰 ( 以下稱為「活動」) 的推廣期為 2026 年 1 月 31 日至 2 月 1 日、2 月 7 日至 8 日、2 月 14 至 15 日、2 月 17 至 22 日、2 月 28 日至 3 月 1 日及 3 月 7 日至 8 日 ( 共 16 日 )。
